I am still working on that idea and dedication to being joyful in all things; grateful of all things; and being exceedingly glad in my persecutions, trials and tribulations. How far ahead of me are you in your own little entertainments from men in this place called earth?

The Case worker is not due back from her vacation until Wednesday; and the Secretary who informed me that I was approved was in just 2 days this week; so hopefully something will move along on the transfer before the end of the week; or before the Court asks teh Marshals to bring me again in chains to Oklahoma.

Yes, of course the sooner I get to Oklahoma and a decision on the 2255, the sooner I can be home, Or get on with the appeals. And yes; it would be far esier to prosecute the appeal from Herlong; but that is being really humanist about the process. I am well aware that me against them is not a fair fight; in natural terms they have me so outnumbered, and overpowered that ther is no chance of me winning on my own. HOWEVER, I AM NOT ALONE: AND HE THAT IS IN ME IS FAR MORE POWERFUL THAN HE THAT IS IN THEM so that it is really not a fair fight at all as I have already been given the VICTORY in JESUS as more than an overcomer... PRAISE GOD!

One of my major tasks is keeping myself centered in and on the real contest of Good v evil, knowing that Good like GOD wil always overcome evil. I have to keep me concentrated on maintining my faith and confession so that I remain on the side of good; and wholly within God's will for the situation.

I have had a significant battle between heart and mind, as my mind wants to drag me off into a war of words by man's traditions that make the laws of God of no effect. Everything I read in law and case history gives more evidence that this man in a black dress is simply too corrupt and too ignorant of his limitations to ever overcome his person and pride for justice sake.

Much to my chagrin I learned yesterday that my scheduled departure from La Tuna ia February 9, 2009.

But the really disgusting part of this is that I am scheduled to be in Herlong on the 10th by greyhound bus. I am sure someone really creative can find that trip on the internet and likely realize that it just flat can not happen.

The nice Secretary who said on December 18 that she would have me out within a month forgot that 53 days is not a month... OOPS!

This likely means that I will either be routed completely around Phoenix, or there has to be a really short time for connections. The others who made this trip both ways took 5 days; so one of the extra benefits is that by this schedule I will be given food allowance for 1 day when I leave here. It could be hungry along the way; but I am very familiar with fasting for 3 or 4 days at a time so not really a problem. And of course sitting on a bus for over 24 hours not a lot of energy is consumed.

The real situation is that it is far more likely that I will be on my way back to court in chains before a transfer can occur. That provides the government another chance to strip me of my legal materials to create a "fair fight" and "level playing field" as required by precedent.

At least 2 of you as my loyal helpers will be asked for specific things to help me be better prepared for all those possibilities. Or maybe it is time to shut up and live by my own confession of faith to let the HOLY SPIRIT give me the words to say. Yes; of course; those who observed me before in trial and hearings know that; with all my scripting, preparation, and rehearsal I never have done it just my way; and often tempered my actions and words.

Could it be I was too gentle in rebuking all evil? HMMH!

Any plan and idea of meeting as I travel through Phoenix, LA or anywhere else will have to be very flexible. Thank you for your patience and your effort.
